Board members reserve the right to visit the district and communities of a candidate prior to a final decision.

THE DISTRICT

The Charter Oak Unified School District Office is located in Covina and also serves students in the surrounding communities of Glendora and San Dimas. The District unites the three cities and extends from Grand Avenue on the west, to Valley Center on the east, and from a northern boundary near the 210 Freeway, to Covina Hills Road on the south.

The first Charter Oak School Opened on September 9, 1894 with 24 students. From that early start, the District has grown into an award-winning unified district with distinguished schools serving 4,800 students on eight campuses, including one comprehensive high school, one middle school, five elementary schools and one alternative site which is home to a community day school, continuation high school, and a virtual academy.

Charter Oak is a community where people are proud to live. Charter Oak joins the heritage of San Dimas, Glendora, and Covina to form its own identity.

THE COMMUNITY

Covina, founded in 1882, is seven square miles and located in the heart of the East San Gabriel Valley, approximately 22 miles east of Downtown Los Angeles. It is centered in the midst of Interstate freeways 10, 210, and 605, and State Route 57. Covina's population is approximately 47,880 yet, back in 1900, it was known as one of the smallest cities in the whole country.

Special attention has been given to preserving Covina's old-town Downtown feel. The Downtown Specific Plan was developed to promote pedestrian and transit-oriented development while honoring its downtown historical character. Visitors enjoy "mom and pop" shops and can spend a nostalgic day in downtown dining in fine eateries, visiting vintage clothing stores, hobby shops, antique stores, and ice cream shops. The renovated Center for the Performing Arts (CCPA) is a \$10 million facility that serves as the architectural and entertainment cornerstone of Downtown.

Downtown serves as a gathering spot for citizens to participate in special and charity events. Such occasions bring the community together and fosters goodwill between Covina's elected officials, City staff and the community.
